Presentations and Discussions

- Update on Sewer in the Town: No discussion.
- Update on signage entering Massena: Councilwoman Cunningham reported that the signs are in very rough shape. Ownership of the signs has been undeterminable, so work has begun with the Chamber of Commerce to continue the project. Councilman Carbone indicated that he would like to get a letter from the Chamber stating the Chamber has no interest in the signs. The project would involve removal and replacement of two signs, determining a new location for new signs, and obtaining a grant to help fund the project. (See Resolution, below).
- Update on Fishing Tournament: Councilman Miller provided an update on the status of the tournaments, noting that the dates and information about the have been added to the Town of Massena's calendar (www.massena.us). He also noted that Clarkson University has been advocating for and helping market the tournaments on behalf of the Town. Video phones are being installed by NYPA, which along with the US Customs app, should make travel along the St. Lawrence River easier for tournament registrants. There has been much interest in the creation of a fishing school, funded in part through completion of a Consolidated Funding Application (CFA). Councilman Carbone offers to assist with the grant writing. (See Resolution, below).
- Bids for Wastewater Rehab on Highland Road: No discussion.
- **Discussion on Moratorium on Solar Farms:** A draft Local Law enacting a moratorium on all solar energy system development operating with the Town is distributed. It is noted that no official action can be taken without first holding a public hearing, with action anticipated at the next (August) meeting.
